## LCDD/23dance Company: COVID-19 Guidelines

**Covid-19 Protocol and Guidelines**: In compliance with restrictions from local and federal agencies, we have listed safety procedures and precautions for studio staff, parent/guardian, and students. Please be advised that participation in dance classes at LCDD/23dance Company is voluntary and all risks associated with participation in our dance program will be the responsibility of the attending student and/or parent/guardian.

## CDC recommendations and guidelines are followed by students and staff.

**Entering and Exiting the Studio:** Parents drop off and pick up students at the front door. Parents/guardians, sitters/transporters, may not wait inside the studio area before, during, or after class. Staff will meet you at the front door to take your student to the proper class, and will bring them back to the front door to dismiss once class is over. During entry and exit times, students enter to the left of the main studio and exit to the right of the main studio. During heavy traffic transition times, your student may be asked to enter the studio 5-10 minutes before class begins.

**What to Bring:** No outside food or drink is permitted in the studio except bottled water. A small dance bag with all your dance shoes and belongings is allowed and will be brought into the studio area with your dancer. Cubbies will not be used at this time, and the pass-through hallway between studios will not be used as a waiting room, or a place for storage of your belongings. We ask that dancers come dressed for class whenever possible to help expedite the flow of class entrances and exits.

**Face Covering:** Parents who have business to attend to inside the studio office, must wear face coverings. Students over the age of 5 years, must wear face coverings while entering and exiting the studio, and are required to be worn during class.

**Temperature Checks:** Dancers and staff will have temperature checks using a contactless thermometer. Anyone with a temperature of 100.4 degrees will not be permitted to remain on site. Please do not come to class if you are not feeling well, or have symptoms.

**Enhanced Cleaning:** We routinely disinfect and sanitize all common areas and surfaces of our studio space, including bathroom, doors and windows, and flooring. Hand Sanitizer is available at stations throughout the studio.

**Social Distancing:** Social distancing grids have been placed in both studios where students can maintain the recommended distance from each other. Per regulations, dancers do not have to social distance during choreography sessions, particularly when partner work such as lifts occur. *Parents/students understand that in the event dancers touch, share a prop, or are in close proximity during formations and lifts, parents/students accept full responsibility, and hold harmless LCDD/23dance Company and the staff and management of any and all liability should your student or you become ill. By registering for dance classes at LCDD/23dance Company you assume all risks associated with participation, and agree to the terms and conditions of the directives that have been established concerning COVID-19 and our business.*
