Registration Terms and Conditions: \$25 Non-Refundable Registration Fee is charged to enroll.

Tuition is based on 9 monthly payments due on the 1st class of each month September through May. Summer Classes and/or Summer Dance Camps are billed separately and are paid in full prior to each session.

Monthly fees for tuition only will be drafted on the 1ST of each month beginning in September.

<u>September tuition will be drafted on the first class your student attends, and will be prorated, if applicable.</u>

Costume and Recital fees will be included in these transactions and will be drafted separately by quarter on the date they are due. If you choose to pay by cash or check, these fees will be due on the 1St of each month with a \$25 late fee assessed for tuition received after the 10th of each month.

Costumes and Recital Fees: Statements for your Student's Costume and Recital Billing account will be billed quarterly and will be listed separately on your billing statement. Your TUITION auto payment TRANSACTION will be noted on your statement. Your account ledger identifies charges and payments, specific categories, check #'s, and transactions for your account. <u>Costumes</u>: Costume deposits are due November 15th & January 15th, and are non-refundable. Costume balances are due March 15th. A \$25 deposit per costume, per student, per class is charged. Based on our previous season's costume costs, our recital costumes average \$75 per costume. This price will not include accessories such as shoes or tights, if applicable.

<u>Multiple Costumes</u>: Ensemble students and/or students who participate in multiple classes or families with multiple student participants will be charged a portion of their costume fees per each quarter. Costume balances are due March 15th. Students and Parents will be notified as costumes arrive from the manufacturer, and costumes will be distributed as balances are received.

<u>Spring Recital</u>: Sunday May 22, 2022 / McAlister Auditorium Furman University / Recital Fee Payable February 15th of the 2nd quarter. If your student does not wish to participate in Spring Recital, do not pay Costume Deposit or Recital Fee. No withdrawals after March 30th. Students who do not participate in Spring Recital do not attend class after March 30th.

<u>Withdrawal from Class/No Refunds</u>: Written notification of withdrawal from class via email is required 15 days prior to your withdrawal, to discontinue all scheduled processing of fees and transactions. No refunds for transactions previously processed.
